

# Full Independent Licence - Stream 2

First Time Licensure for Family or Specialists Practice for physicians that **do not** hold a licence in another Canadian jurisdiction. (i.e. new grads)

## Step 1

Apply for Yukon licensure via [Physicians Apply](#).

## Step 2

Request certificates of professional conduct (also known as certificates of standing) be sent to YMC from all jurisdictions where have been licensed (including educational) in the past 20 years. These must be submitted to us directly from the regulatory bodies.

## Step 3

Await a notification from our office that your online profile has been created and use the links to sign in and edit your profile. You must then upload the following documents

- Proof of completion of the [Yukon First Nations 101 course](#). You must complete this course in order to obtain a licence in the Yukon.
- A copy of your CV.
- Proof of CMPA insurance indicating coverage in Yukon.
- A copy of a Canadian government-issued identification (e.g., passport) Note: you can share this document with us directly through Physicians Apply.

## Step 4 **Important**

Complete and submit your Licence Application.

\*\*If you do not see an “apply” button, you are likely missing supporting documents

## Other information:

- Once our office has received all your certificates of standing, your file will go for YMC review.
- Once approved, you will receive an email requesting you log in and pay. Once your payment is received your licence will be released.

Note: at this time licences only appear on the public register on the effective date. You can download a copy of your licence if required for privileges or billing set up purposes

- Full Independent licences must be renewed annually. You will be sent a reminder email with links to renew and instructions on striking your licence if you wish to cancel Yukon licensure.
- The average time to process an application is 4 weeks. However, If you do not hear from us with 10 days please reach out the [YMC@yukon.ca](mailto:YMC@yukon.ca)

## Next steps

- You must apply for hospital privileges after getting your Yukon licence and before providing patient care in Yukon hospitals. You must initiate this process directly with the Yukon Hospital Corporation . [yhchospitalprivileges@wgh.yk.ca](mailto:yhchospitalprivileges@wgh.yk.ca)

- If you are practicing medicine through a corporation, you must [apply for a professional corporation permit](#).

## Minimum Licensing requirements

Physicians wishing to practice medicine in Yukon must:

- be a licentiate of the Medical Council of Canada; and
- hold:
  - a certificate of fellowship from the Royal College of Physicians and Surgeons of Canada (or a specialty certification issued by the Collège des médecins du Québec; or
  - the College of Family Physicians of Canada (or a family medicine certificate issued by the Collège des médecins du Québec

**or**

- hold a current full licence in another Province or Territory of Canada that is a party to the Canadian Free Trade Agreement. (CFTA)
